## **DIRECTIONS TO THE ATHLETIC CLUB OF COLUMBUS**

### **From SOUTH of Columbus:**

- Interstate 71 North to Interstate 70 East. Promptly move into the lane which is second from the right.
- Exit at Fourth Street/Livingston Avenue, which is immediately after the Front Street Exit. At the top of the ramp move into the lane which is second from the far left.
- At the light, which is Fourth Street., turn left while remaining in your lane.
- After about 5 blocks, look for the intersection of State Street. The next street will be Broad Street. Turn left on Broad Street.
- The Club is on your immediate right. Look for the blue canopy.

### **From NORTH of Columbus**

- Interstate 71 South to the Broad Street exit (shortly after exit for Spring Street) Turn Right on Broad Street.
- The Club is about 8 blocks from here, on your right, immediately past the intersection of Fourth Street. Look for the blue canopy.

### **From WEST of Columbus**

- Interstate 70 East, exit at Fourth Street/Livingston Avenue, which is immediately after the Front Street Exit. At the top of the ramp move into the lane which is second from the far left.
- At the light, which is Fourth Street., turn left while remaining in your lane.
- After about 5 blocks, look for the intersection of State Street. The next street will be Broad Street
- Turn left on Broad Street.
- The Club is on your immediate right. Look for the blue canopy.

### **From EAST of Columbus**

- Interstate 70 West, to the Fourth Street Exit (shortly after the exit to Interstate 71 North). Turn Right.
- After about 5 blocks, look for the intersection of State Street. The next street will be Broad Street.
- Turn left on Broad Street.
- The Club is on your immediate right. Look for the blue canopy.

### **From NORTHWEST of Columbus**

- Take 315 South to Merger 670 East.
- Exit at Broad Street and Turn Right. Broad Street Turn left on Broad Street.
- The Club is about 8 blocks from here, on your right, immediately past the intersection of Fourth Street. Look for the blue canopy.

### **PARKING:**

- The parking lot is located on the east side of Fourth Street between State and Broad Streets. There is a parking attendant available from 8:00 a.m. until 4:00 p.m.

### **OTHER POSSIBLE PARKING OPTIONS:**

- Central Parking lot directly across from The Athletic Club -- -- on left side of Fourth Street, behind National City Bank (also on Fourth Street between State Street and Broad Street).
- Underground parking under the State House - entrances on Third Street and Broad Street
- City Center Parking Garage - entrance on Third Street
- Self park lot on the corner of Fourth Street and State Street
- Galleria Parking Garage - entrance on Fourth Street
