V. THE DOMESTIC INDUSTRY HAS BEEN MATERIALLY INJURED AND IS THREATENED WITH MATERIAL INJURY BY REASON OF UNFAIRLY TRADED SUBJECT IMPORTS

A. Legal Standard

The Commission must determine whether a domestic industry is materially injured or is threatened with material injury by reason of the dumped and/or subsidized imports.¹⁶ The statute defines “material injury” as “harm which is not inconsequential, immaterial, or unimportant.”¹⁷ The Commission examines the “significance” of the volume and price effects of the dumped and/or subsidized imports, and the impact of those imports on the condition of the domestic industry, when investigating if a domestic industry is materially injured or threatened with material injury “by reason of” dumped and/or subsidized imports.¹⁸ The Commission’s analysis must consider the prevailing conditions of competition in the U.S. market.¹⁹

Under the “by reason of” standard, the Commission must “ensure that subject imports are
